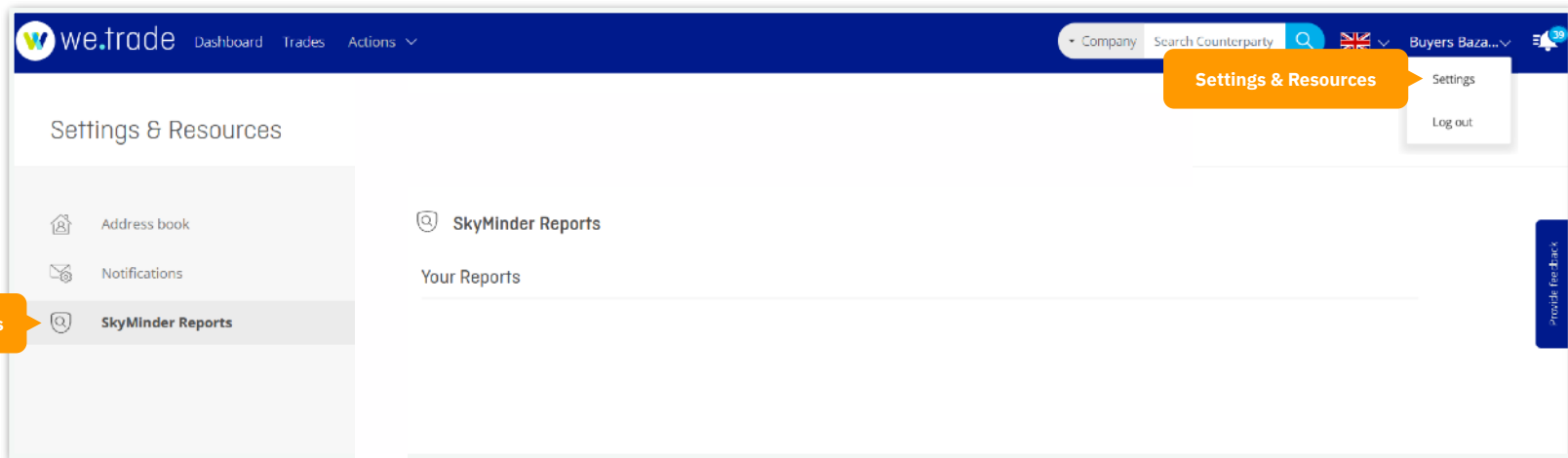

- For an appointed administrator when in **‘Setting & Resources’** they will see both **‘Integrations’** and **‘SkyMinder Reports’**
- It is very important than your appointment we.trade administrator has Registered the SkyMinder Account
- If a trader selects ‘SkyMinder Reports’ within the Settings & Resources > SkyMinder Reports section and the appointed we.trade administrator has NOT registered. A banner will appear again advising the trader to contact their company admin to register.
